New process for eligible students in 11th or 12th grade to receive SAT Fee Waivers.



Student Eligibility:

Eligible students must be in 11th or 12th grade to use fee waivers for SAT Weekend.

Fee waivers are available to high school students who meet at least one of the eligibility qualifications listed below. College Board Fee Waiver Qualifications:

- A student must be either enrolled in or eligible to participate in the National School Lunch Program (NSLP) to get a fee waiver.
- If the primary eligibility indicators can't be used, use the additional indicators to determine student eligibility. Additional Fee Waiver Eligibility Indicators:
- The student's annual family income falls within the Income Eligibility Guidelines set by the United States Department of Agriculture (USDA) Food and Nutrition Service.
- The student is enrolled in a federal, state, or local program that aids students from economically marginalized families (such as TRIO programs like Upward Bound).
- The student is unhoused or resides in federally subsidized public housing or a foster home.
- The student is a ward of the state or an orphan.

How to request SAT Fee Waivers

Receive Benefits Through the SAT Fee Waiver Request Form Starting in late Fall 2023, students will be able to access the SAT Fee Waiver Request Form through the main fee waiver webpage, sat.org/feewaivers.

After submitting responses to a few questions on a form, students may receive approval for fee waiver benefits by email within a few days. College Board may reach out to adult contacts that the student provides to confirm their fee waiver eligibility. Once approved, students will see their fee waiver benefits loaded into their account. ACT

To receive ACT Fee Waiver Benefits students must be in 11th or 12th grade and meet the same income eligibility criteria.

Students must request a fee waiver from their high school.

Students at Mitchell High School must request an ACT Fee Waiver from Career Specialist, Mrs. Chamberlin.

Students are eligible for up to 4 fee waivers. Student must request a waiver for each test.

General Income Guidelines for SAT & ACT Waivers

| NUMBER OF MEMBERS IN HOUSEHOLD ¹ (including head of household) | TOTAL ANNUAL INCOME ² (in preceding calendar year) |

| 2 | \$36,482 |

1. The household size should be the number of household members including the filer on the family's current tax statement. A student who is in foster care is considered a household size of 1 person.
2. Income levels are based on the USDA Food and Nutrition Service Income Eligibility Guidelines at 185% of the federal poverty level, as used by schools, institutions, and facilities participating in the NSLP (excludes Alaska and Hawaii).

To determine income levels for families with more than 6 household members, take the annual allowance for 6 members, \$74,518, and add \$9,509 for each additional member.
